REGULAR AGENDA ITEM: Partial Vacation of County Road 85 Right of Way

A landowner adjacent to CR 85 on the northwest side of Mille Lacs Lake recently requested that we vacate the outer 40 feet of the 100-foot right of way that MnDOT reverted to Aitkin County when US Hwy 169 was realigned many years ago. My office has reviewed this request and is agreeable to the proposed vacation. The attached resolution provides for the vacation of right of way as described.

WHEREAS, Aitkin County acquired right-of-way on Aitkin County Road No. 85 as a Trunk Highway Turnback from the Minnesota Department of Transportation, and

WHEREAS, portions of excessively wide right-of-way can restrict a landowners ability to improve the property, and

WHEREAS, a landowner has requested the vacation of the outer 40 feet of way through his property to reduce the right-of-way width from 100 feet to 60 feet, measured from the centerline of County Road No. 85, and

WHEREAS, it has been determined that the right-of-way is excessively wide in this area and therefore can be reduced to a width of 60 feet from the centerline of County Road No. 85.

NOW THEREFORE, BE IT RESOLVED, that the portion of Aitkin County Road No. 85 right-of-way hereinafter described is hereby vacated so that the property reverts to the owner of said property.

That part of the existing right-of-way for County Road 85 (also known as Pike Avenue) that is located in the Southwest Quarter of the Northeast Quarter of Section 6, Township 44, Range 27, Aitkin County, Minnesota, that lies southeasterly of and southwesterly of the existing southerly right-of-way line for Trunk Highway 169 and that lies between a line 60 feet northwesterly of and parallel with and a line 100 feet northwesterly of and parallel with the centerline of said County Road 85.

It is intended to extend or shorten the sidelines of said vacated right-of-way so as to intersect the south line of said Southwest Quarter of the Northeast Quarter and the southerly right-of-way line of said Trunk Highway 169.
