At Tuesday's meeting the County Board will need to schedule a Public Hearing for the Budget hearing as required by the legislature. It is staff's recommendation to hold the meeting on Tuesday, December 3<sup>th</sup> at 6:05 p.m. in the County Boardroom.

Historically this meeting has been referred to as the Truth in Taxation meeting. The Board has the ability to set the meeting any date from November 27<sup>th</sup> thru December 26<sup>th</sup>. This Board has taken the approach to digest the comments from the "public hearing" prior to adopting a final levy. Staff is attaching calendars for November and December for your review. At this time the County Board has regular Board meetings scheduled for November 26<sup>th</sup>, December 10<sup>th</sup> and December 24<sup>th</sup>. Health and Human Services meetings are scheduled for November 26<sup>th</sup> and December 17<sup>th</sup>.

Additionally, this year's AMC Annual Conference is scheduled for Sunday, Monday, and Tuesday, December 8th- 10<sup>th</sup> in Minneapolis. The exact schedule of events has not been set, but it could mean that the Board would not meet on December 10<sup>th</sup>.
