Project overview

- 7.1 Administrative Expenses \$74,686: Health & Human Services is proposing to purchase a new Electronic Document Management System (EDMS) system for Financial Services, Child Support and Social Services as one of the current electronic systems contracts is being terminated and no longer a viable option. The purchase of this one system will allow for all these departments to be on the same platform and allow ease of access for internal staff as well as consumers. Tentative timeline for implementation is to have departments up and running by end of year 2024.
- Identify the dollar amount of the total project spending that is allocated towards evidence-based interventions for each project in the Public Health (EC 1), Negative Economic Impacts (EC 2), Services to Disproportionately Impacted Communities (EC 3), Infrastructure (EC 5) Revenue Replacement (EC 6) and Administrative (EC 7) Expenditure Categories. - 7.1 Administrative Expenses \$74,686: Health Human Services is requesting funding to support a portion of the initial implementation cost of the CaseWorks system. Total one-time implementation cost on the high end of the proposal is \$452,217.
