- o \$15 million in Governor's supplemental budget
- House \$9 million for SSIS upgrades, Rep Pinto HF2476

- Held interviews for open Child Protection (CP) position which has been open since January 4th. An offer was made.
- We have an upcoming retirement in HCBS team, last day May 8th, started the hiring process.

- Both CP and HCBS have seen turn over and have been in coverage.
