

**CSAH 11 Speed Zone Study**

**WHEREAS**, Aitkin CSAH 11 is part of the 6.5 mile segment of Tame Fish Lake Road from US Hwy 169 in Aitkin County to TH 6 in Crow Wing County, and

**WHEREAS**, a 45 mph speed zone was established by the Minnesota Department of Transportation in 2003 for a 1.2 mile segment of Aitkin CSAH 11 in the vicinity of Horseshoe and Farm Island lakes, and

**WHEREAS**, the 55 mph statutory speed limit on CSAH 11 west of this established 45 mph speed zone appears to be inconsistent with an established 50 mph speed zone on Crow Wing CSAH 14 beginning at the county line,

**NOW THEREFORE BE IT RESOLVED**, That the Aitkin County Board of Commissioners requests the Minnesota Department of Transportation to perform a speed zone study on the 3.2 mile segment of Aitkin CSAH 11 from US Hwy 169 the Crow Wing County line.


