Summary of Issue:				
The Aitkin County Planning Commission met for a Public Hearing on September 16, 2024 to discuss an "Ordinance Limiting the Number of Retail Businesses Selling Recreational and Medical Cannabis in Aitkin County to Two". The Planning Commission voted unanimously to approve and forward to the Aitkin County Board of Commissioners for approval or denial. After further discussion, it is understood that an ordinance is not necessary, and that a proposed resolution can be denied or adopted by the County Board. A RESOLUTION LIMITING THE NUMBER OF RETAIL BUSINESSES SELLING RECREATIONAL AND MEDICAL CANNABIS IN AITKIN COUNTY TO TWO

WHEREAS, the 2023 Session Laws, Chapter 63, (House File 100), Chapter 342.13(3) (i) of Minnesota State Statute states, "A local government that issues cannabis retailer registration under section 342.22 may, by ordinance, limit the number of licensed cannabis retailers, cannabis mezzobusinesses with a retail operations endorsement, and cannabis microbusinesses with a retail operations endorsement to no fewer than one registration for every 12,500 residents; and

WHEREAS, Aitkin County's most recent estimated population from 2022 was 16,614, and Chapter 342.13 (3) U) states, "If a county has one active registration for every 12,500 residents, a city or town within the county is not obligated to register a cannabis business"; and

WHEREAS, the Aitkin County Board of Commissioners finds the consideration of an Ordinance on limiting the number of retail businesses selling recreational and medical Cannabis in Aitkin County for the preservation of the public peace, health, morals, safety, and welfare and because of the inherent risk of injury to persons related to the enactment of 2023 Session Laws, Chapter 63, (House File 100), allowing for the use and possession of Cannabis and other products containing THC ("Cannabis Products"); and

WHEREAS, pursuant to Minnesota Statute 394.34, the Aitkin County Board of Commissioners deems it necessary to adopt an Ordinance placing a limit on the number of retail businesses selling recreational and medical Cannabis before January 1, 2025, and at which time official controls shall be in place; and

WHEREAS, the Aitkin County Board of Commissioners finds:

1. The institution of a zoning ordinance in order to limit the number of retail businesses selling recreational and medical cannabis shall be adopted and implemented, to protect the public health, safety, and general welfare of the residents of Aitkin County.

2. Aitkin County has received the State Model Cannabis Ordinance from the Office of Cannabis Management, but currently does not have official controls in place to regulate the sales, testing, cultivating, manufacturing, and distribution of Cannabis products. The State of Minnesota began receiving business license applications on July 1, 2024 for an early lottery entry from Social Equity Applicants, which are defined in MN Statutes 342.17.

3. It is in the interests of public health, safety, and general welfare to impose an ordinance limiting the number of retail businesses selling recreational and medical cannabis and be published pursuant to Minnesota Statute 375.51.

NOW, THEREFORE BE IT RESOLVED, that the Aitkin County Board of Commissioners approves and adopts a "Resolution Limiting the Number of Retail Businesses Selling Recreational and Medical Cannabis in Aitkin County to Two".
