The Board has received several budget presentations over the past two months outlining the details of each budget. The Budget Committee is recommending a 4% levy increase in the amount of \$18,205,637. The Board will have the opportunity to discuss this amount and pass the 2025 preliminary levy resolution.  State statue requires the Board to pass a preliminary levy no later than September 30th each year. The final levy may be reduced by December but cannot be raised higher than the preliminary levy amount.
